Resolution No. 181 s. 2023

WHEREAS, the Civil Service Commission Regional Office I invited bidders for the Project: *Procurement of Security Services for CSC Regional Office I for CY 2024 (Early Procurement Activity)* with ITB Number: 2023-10-001;

WHEREAS, the Approved Budget for the Contract (ABC) is One Million Nine Hundred Ten Thousand Pesos (PHP 1, 910, 000.00);

WHEREAS, a pre-bid conference was conducted today October 11, 2023;

WHEREAS, during the pre-bid conference, a prospective bidder clarified whether the administrative fee/cost included in the ABC is at least 20% of the total contract price pursuant to Republic Act No. 11917 or The Private Security Services Industry Act;

WHEREAS, after verification with the Department of Budget and Management and Department of Labor and Employment, the undersigned BAC Members deemed it appropriate to adjust the computation of administrative fee/cost to twenty-two percent (22%) of the total contract price to comply with the pertinent provisions of Republic Act No. 11917 and its Implementing Rules and Regulations;

WHEREAS, the recomputed amount of ABC is Two Million and Thirty Thousand Pesos (PHP 2,030,000.00) which is more than the ABC of the Project as indicated in the bidding documents;


WHEREAS, to comply with the pertinent provisions of Republic Act No. 11917 and its Implementing Rules and Regulations, the undersigned BAC Members resolved to recommend to the Head of the Procuring Entity the following:

1. Cancellation of the bidding of the Project with ITB Number: 2023-10-001;
2. Increase of the ABC from One Million Nine Hundred Ten Thousand (PHP 1, 910, 000.00) to Two Million and Thirty Thousand Pesos (PHP 2,030,000.00); and
3. Re-posting/republication of the Project and its bidding documents with the new ABC of Two Million and Thirty Thousand Pesos (PHP 2,030,000.00).
