**RESOLUTION**

WHEREAS, the Civil Service Commission Regional Office I invited bidders for the Procurement of Security Services for CSC ROI for CY 2024 – Early Procurement Activity (EPA) with an Approved Budget for the Contract of Two Million Thirty Thousand Pesos (P 2,030,000.00);

WHEREAS, during the Detailed Bid Evaluation on November 6, 2023, Itawes Security Proactive Agency, Inc. and Ranniag Security Services, Inc. were found to be eligible/compliant to the technical and financial requirements with the Lowest Calculated Bid amounting to One Million Nine Hundred Ninety Eight Thousand Two Hundred Sixty Six Pesos and 40/100 (Php 1,998,266.40);

WHEREAS, the Technical Working Group conducted a Post-Qualification on November 9 and 10, 2023 of Ranniag Security Services, Inc. and Itawes Security Proactive Agency, Inc. respectively;

WHEREAS, upon deliberation of the post-qualification results conducted on November 17, 2023, the BAC declared Itawes Security Proactive Agency, Inc. and Ranniag Security Services, Inc. as the bidders with the Lowest Calculated and Responsive Bid (LCRB);

WHEREAS, in a meeting held on November 17, 2023, the BAC agreed to break the tie through drawing of lots pursuant to Section 3.3 of the GPPB 06-2005 Tie Breaking Method, Annex 11 of the 2016 IRR of RA 9184;

WHEREAS, Ranniag Security Services and Itawes Security Proactive Agency, Inc. were notified on November 20, 2023 for the conduct of the Tie-Breaking Activity on November 23, 2023;

WHEREAS, due to unforeseen circumstances, the BAC moved the Tie-Breaking Activity on December 4, 2023 at 9:00am;

WHEREAS, on December 4, 2023, both representatives from Itawes Security Proactive Agency, Inc. and Ranniag Security Services, Inc. were present for the Tie Breaking Activity and Itawes Security Proactive Agency was picked during the drawing of lots;

WHEREFORE, the BAC hereby resolves to recommend to the Head of the Procuring Entity (HOPE), Itawes Security Proactive Agency, Inc. as the Lowest Calculated and Responsive Bidder for the awarding of contract.
