- f. The government employee may be allowed to purchase tickets for a bigger group of more than 5 persons, upon presentation of an authorization letter from the group members.
- g. Ticket purchase is on cash basis only.
- h. Unused attraction tickets after validity period will not be accepted to any cash refund.
- i. Add-on attraction tickets can be availed on existing normal rates.
- j. Promo should not be in conjunction with any other promo or discount.
