MEMORANDUM CIRCULAR

FOR : HEADS OF CONSTITUTIONAL BODIES, DEPARTMENTS, BUREAUS AND AGENCIES OF THE NATIONAL GOVERNMENT, LOCAL GOVERNMENT UNITS, GOVERNMENT-OWNED OR CONTROLLED CORPORATIONS WITH ORIGINAL CHARTERS, AND STATE UNIVERSITIES AND COLLEGES

SUBJECT : 2017 18-Day Campaign to End Violence Against Women

Pursuant to Presidential Proclamation No. 1172, s. 2006, the Philippine Commission on Women (PCW) leads the annual observance of the 18-Day Campaign To End Violence Against Women (VAW) on November 25 to December 12, 2017.

This year's theme "**VAW-free community starts with Me**", gives emphasis on everyone's commitment and contributions to ending VAW and the continued pursuit for a common vision of a VAW-free community.

To promote public awareness in the observance of the event, all government agencies are encouraged to undertake related activities, such as:

- Hanging of the official streamer bearing this year's campaign theme. Design template can be downloaded at <http://pcw.gov.ph/VAWfreePH2017>;
- Uploading of the official logo, advocacy materials for the 18-Day Campaign to End VAW in the agency/LGU/organization's official website and social media sites;
- Development of information, education and communication (IEC) materials to raise awareness on VAW like fans and flyers for their clientele. PCW-developed materials may be reproduced by agencies, provided that the content and design of the material is retained. Printer-ready copy of the materials can be downloaded at <https://tinyurl.com/Anti-VAW-IEC>. The uploaded materials are designed for interested organizations to incorporate their official logo below the phrase "Reprinted and distributed by:" so that due acknowledgment could be given to their contribution to the campaign;
- Organizing activities related to this year's theme and focus during the 18-Day Campaign period, with both external and internal stakeholders as participants;
- Participation in the online campaign threads and discussions about the observance using the hashtag #VAWfreePH;
- Participation in the nationwide Orange Your Icon Advocacy initiative;
- Conduct of other anti-VAW activities in line with the agency's mandates and the needs of their stakeholders;
- **For agencies/offices/LGUs in the Greater Manila Area:** Participation in the VAW Experiential Museum at the **Philippine Educational Theatre Association (PETA) Theatre in Quezon City on November 24-26, 2017**. - **For regional/field offices and LGUs:** Coordination with other government regional offices or LGUs in their area for inter-agency / LGU collaboration in holding a regional/local version of the 2017 18-Day Campaign to End VaW Kick-Off activity on November 24, 2017 (refer to Annex 1 for suggested program).

All government agencies are enjoined to participate in the 2017 18-Day Campaign to End VAW. However, it is discretionary on the part of the agency heads to allow their employees to attend on official/business time, as provided for under CSC Memorandum Circular No. 43, s. 1993.

Expenses related to the 2017 18-Day Campaign to End VAW may be charged to the Gender and Development (GAD) Budget of government agencies, following the GAD Planning and Budgeting Guidelines.
