RESOLUTION

WHEREAS, Section 6 of Republic Act No. 6713 otherwise known as the "Code of Conduct and Ethical Standards for Public Officials and Employees", established a system of annual incentives and rewards in order to motivate and inspire public servants to uphold the highest standards of ethics and excellence in public service;

WHEREAS, pursuant to paragraph 2, Section 6 of Republic Act No. 6713, the Special Committee on Award for Outstanding Public Officials and Employees was created "x x x to conduct a periodic, continuing review of the performance of public officials and employees, in all the branches and agencies of the Government and **establish a system of annual incentives and rewards to the end that due recognition is given to public officials and employees of outstanding merit on the basis of the standards set forth in this Act x x x**" (emphasis supplied);

WHEREAS, the Special Committee on Awards for Outstanding Public Officials and Employees for the year 2011 has been constituted and, after thorough evaluation and series of rigid deliberations on the qualified nominations, has chosen ten finalists to be conferred with the **2011 Outstanding Public Officials and Employees or the Dangal ng Bayan Award**;

WHEREAS, pursuant to the above-cited law and the implementing rules and policies on the Honor Awards Program, the Outstanding Public Officials and Employees or the *Dangal ng Bayan* awardees are each given cash reward, trophy designed and handcrafted by National Artist for Sculpture Napoleon V. Abueva, and are likewise provided with a two-night/three-day hotel accommodation to coincide with the September 2011 Awards Rites, among other incentives:

WHEREFORE, the Commission resolves:

- A. To approve the grant of cash reward of **TWO HUNDRED THOUSAND PESOS (P200,000.00)** to each of the following *Dangal ng Bayan* awardees chosen by the Special Committee on Awards for Outstanding Public Officials and Employees or the *Dangal ng Bayan*. In the case of posthumous awardees, the award and cash reward shall be handed over to the surviving spouse or the heirs:
